
The TLP3340 is a photorelay in a 4-pin USOP that consists of a photo MOSFET optically coupled with an infrared LED. The TLP3340 features low output capacitance, C_{OFF} , and thus fast on/off switching of a high-frequency signal, making it ideal for switching applications in high-speed testers.







Fig. 11.1 Switching Time Test Circuit and Waveform








Fig. 12.1.8 t_{ON}, t_{OFF} - T_a




