

Therefore, please design heat release of a device with due consideration to the temperature rise of IGBT.




Fig. 6.2.1 Test Circuit of Switching Time

Fig. 6.2.2 Timing Chart of Switching Time




Fig. 6.2.3 Timing Chart of Switching Loss




Fig. 7.1 Making






Fig. 8.7 V_{CE} - V_{GE}




Fig. 8.9 V_{CE(sat)} - T_c




Fig. 8.11 t_{on} , t_r , $t_{d(on)}$ - I_C




Fig. 8.8 V_{CE} - V_{GE}




Fig. 8.10 t_{on} , t_r , $t_{d(on)}$ - R_G




Fig. 8.12 t_{off} , t_{f} , $t_{d(off)}$ - R_{G}




Fig. 8.13 t_{off} , t_f , $t_{d(off)}$ - I_C




Fig. 8.15 E_{on}, E_{off} - I_C




Fig. 8.17 IF - VF




Fig. 8.14 Eon, Eoff - RG




Fig. 8.16 V_{CE} , V_{GE} - Q_g




Fig. 8.18 I_{rr}, t_{rr} - I_F




Fig. 8.19 Safe Operating Area (Guaranteed Maximum)




Fig. 8.20 Reverse Bias SOA (Guaranteed Maximum)





Fig. 8.21 r_{th(j-c)} - t_w (Guaranteed Maximum)


