### 1. Applications

#### 2. General

The TLP171J photorelay consists of a photo MOSFET optically coupled to an infrared LED. It is housed in a 4-pin package with 2.54-mm lead pitch and 2.1-mm height. This photorelay requires 0.2 mA of LED current to turn it on. It is suitable for applications that need electrical power savings.

#### 3. Features

- (1) Package: SOP(2.54SOP4) (Height 2.1 mm, pitch 2.54 mm)
- (2) Normally opened (1-Form-A)
- (3) OFF-state output terminal voltage: 600 V (min)
- (4) Trigger LED current: 0.1 mA (max)(t≤1s)

- (5) ON-state current: 70 mA (max)
- (6) ON-state resistance:  $60 \Omega$  (max)
- (7) Isolation voltage: 1500 Vrms (min)








Fig. 11.1 Switching Time Test Circuit and Waveform




Fig. 12.1.1 I<sub>F</sub> - T<sub>a</sub>




Fig. 12.1.2 I<sub>ON</sub> - T<sub>a</sub>




Fig. 12.1.3 I<sub>F</sub> - V<sub>F</sub>




Fig. 12.1.4 I<sub>ON</sub> - V<sub>ON</sub>




Fig. 12.1.5 R<sub>ON</sub> - T<sub>a</sub>




Fig. 12.1.6 I<sub>FT</sub> - T<sub>a</sub>






Fig. 12.1.7 t<sub>ON</sub>, t<sub>OFF</sub> - I<sub>F</sub>




Fig. 12.1.8 t<sub>ON</sub>, t<sub>OFF</sub> - T<sub>a</sub>




Fig. 12.1.9 I<sub>OFF</sub> - T<sub>a</sub>





Fig. 12.1.10  $I_{OFF}$  -  $V_{OFF}$
