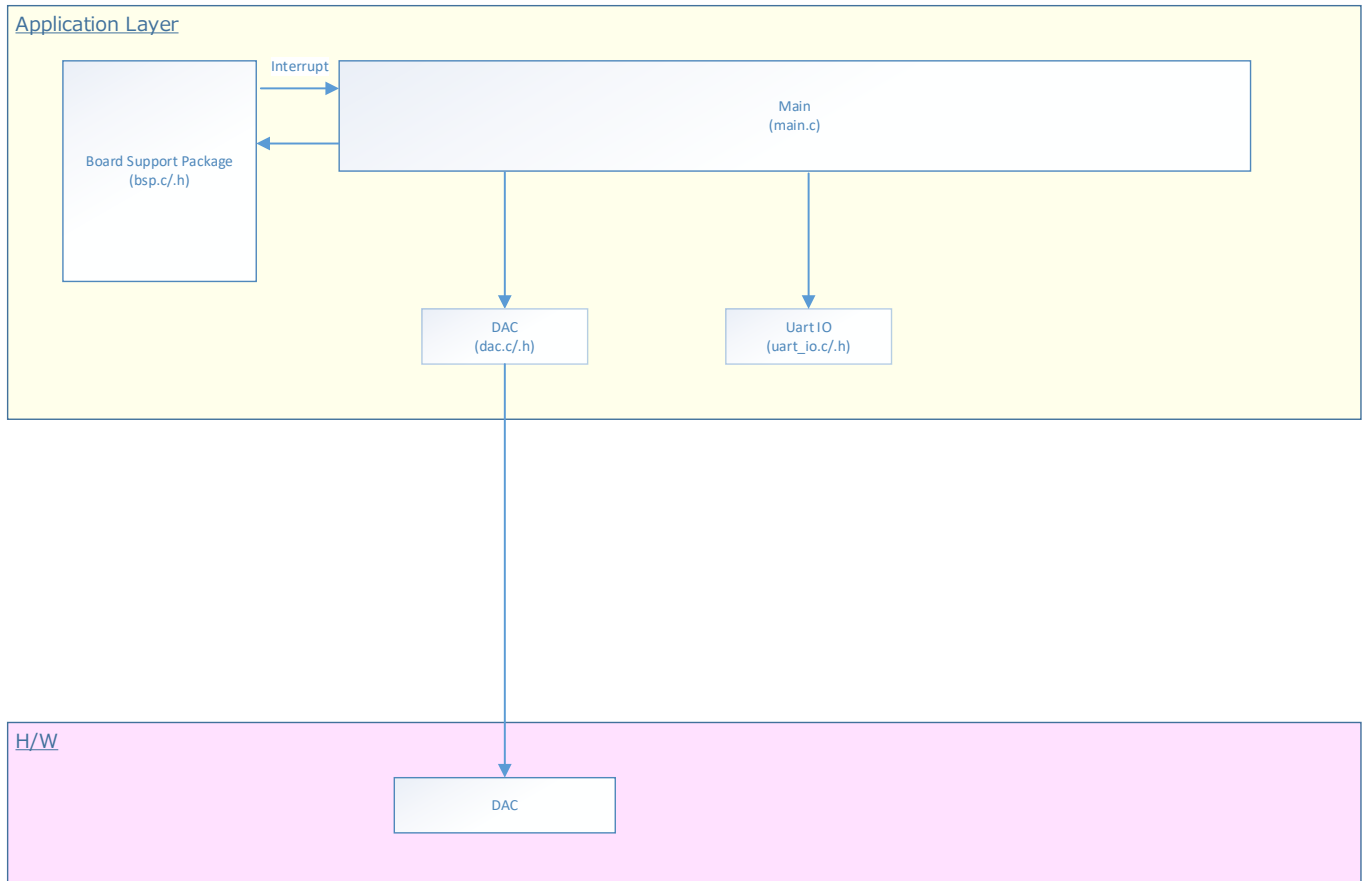

This sample program outputs the analog data to which the DAC converts digital data input from the terminal emulator.

### 6.1. Outlines of Operation

An 8-bit data input from the terminal emulator is received and converted to an analog data. The analog voltage level is output from BSP\_DAC\_0.

### 6.2. Function to Use

The functions to use are as follows.
