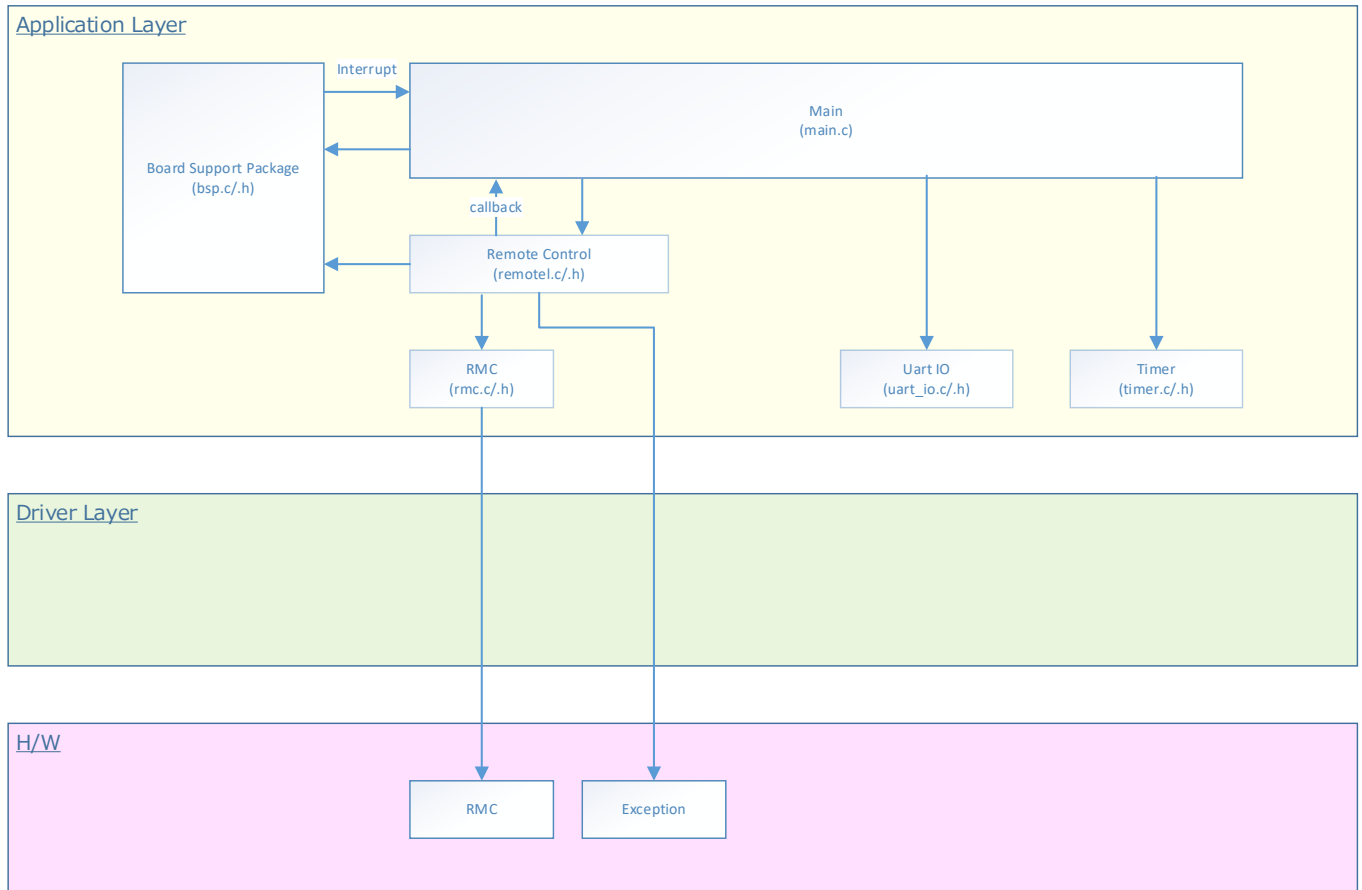

6. Sample Program: RMC_VersionB_UART

This sample software outputs the signal which is received by Remote Control Signal Preprocessor (RMC) to the terminal emulator.

6.1. Outlines of Operation

16-bit customer code, 8-bit data code, and 8-bit reversed data code are received by the RMC. Those data are output to the terminal emulator.

The reception format supports the following two formats.

- NEC format (For the details, refer to 6.2.1 NEC Format.)
- Toshiba format (The same as NEC Format. For the details, refer to 6.2.1 NEC Format.)
- AEHA format (For the details, refer to 6.2.2 AEHA Format.)

For the setting of the format, refer to 6.4 Configuration Setting.

6.2. Function to Use

The functions to use are as follows.

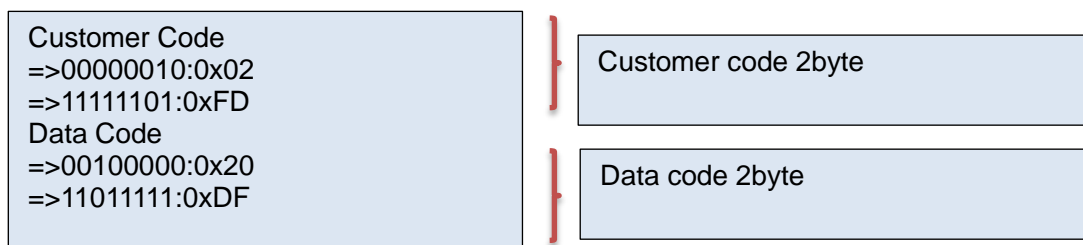

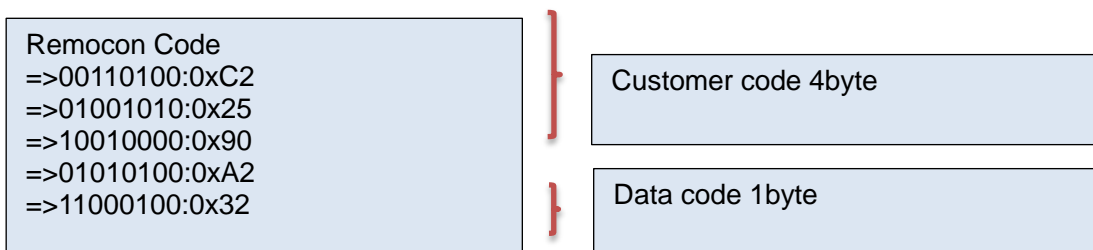
