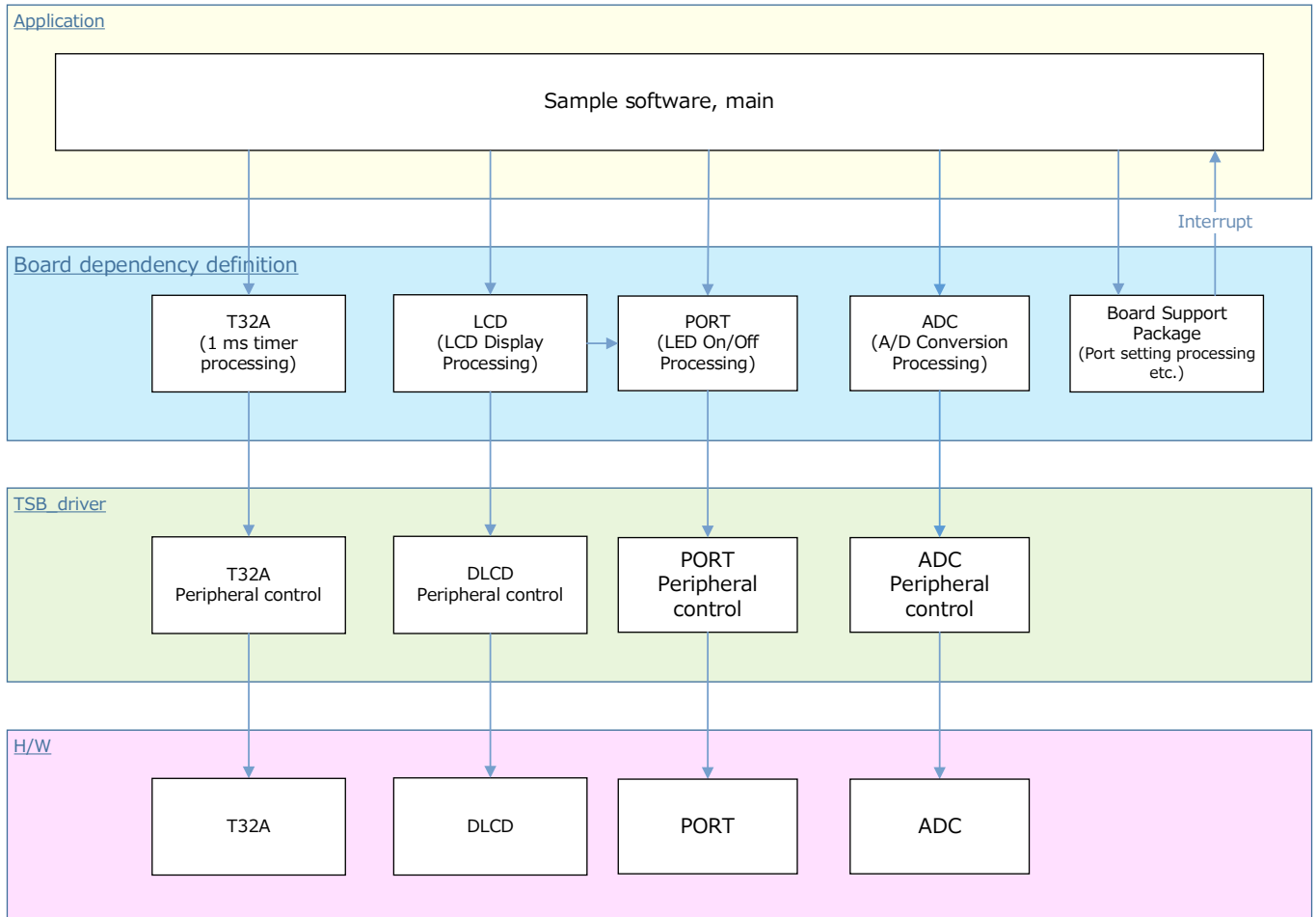

4. Target Sample Program

Sample Program	Outline
DLCD_ADC	Sample program measures voltage after a certain time has elapsed and displays a string on the segment.

6. Sample Program: ADC_NTC_Monitor

This is a sample software that performs A/D conversion of the measured voltage every 100ms and displays the converted value as an 8-digit number on the LCD.

6.1. Outlines of Operation

Uses an interval timer to measure the voltage of a variable resistor and display a string on the segment.

6.2. Function to Use

The functions to use are as follows:

For the Port assignment of each BSP channel, refer to the MCU user guide.

ADC	BSP_VR_1	Variable resistor for voltage measurement
DLCD	BSP_DLCD_1	For displaying measured values
T32A	BSP_T32A_TIMER_1	Interval timer

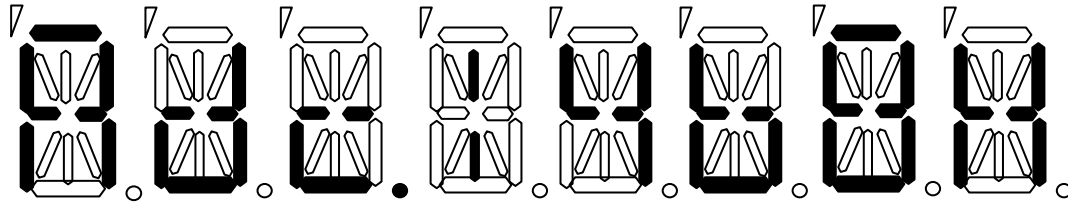

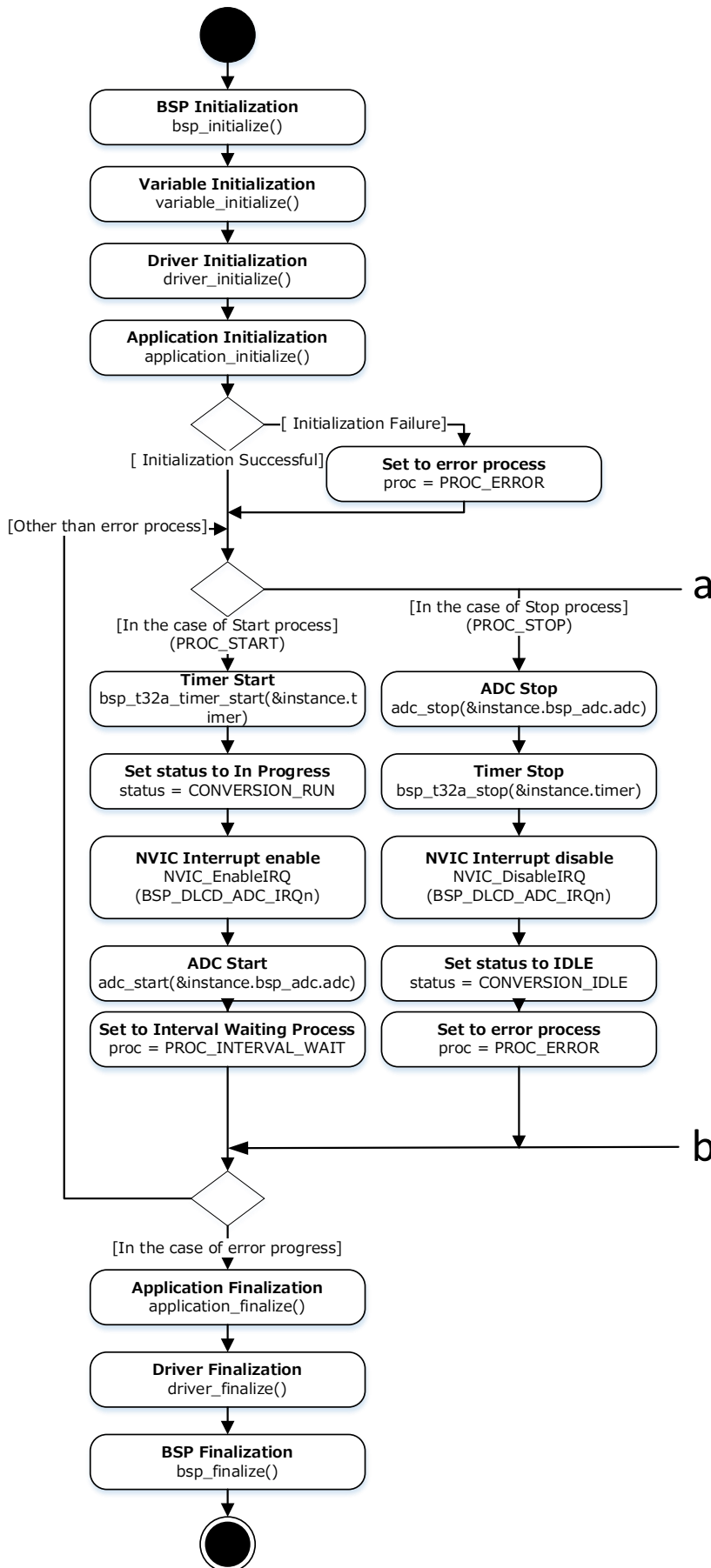

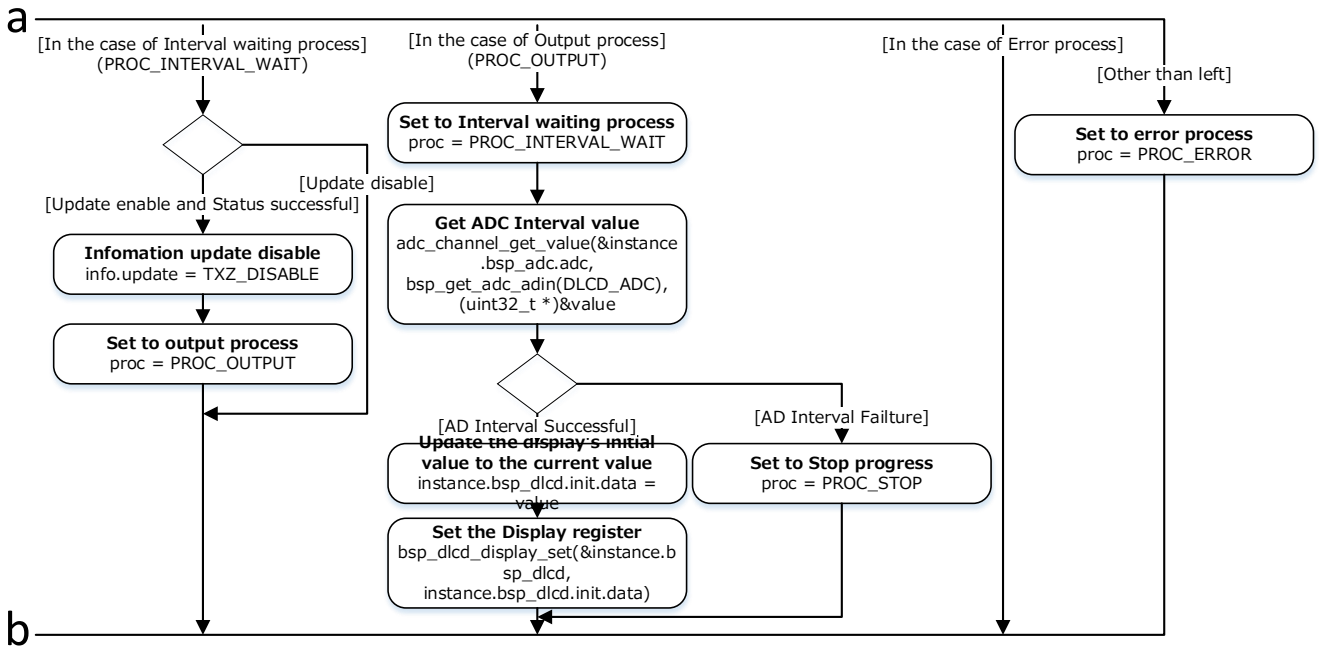
When the AD conversion value '0x4B8' is displayed, the screen will appear as shown below ('Adc.:4b8H' is displayed).



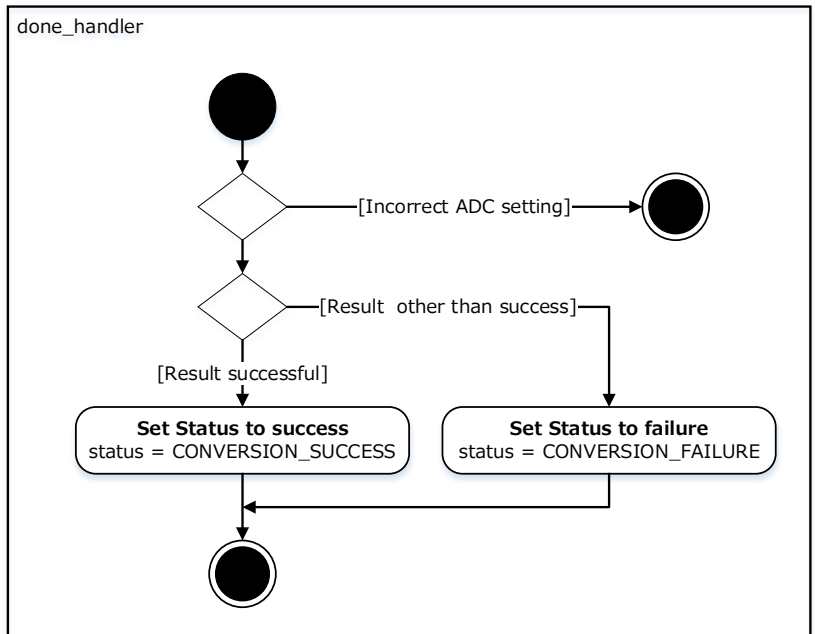
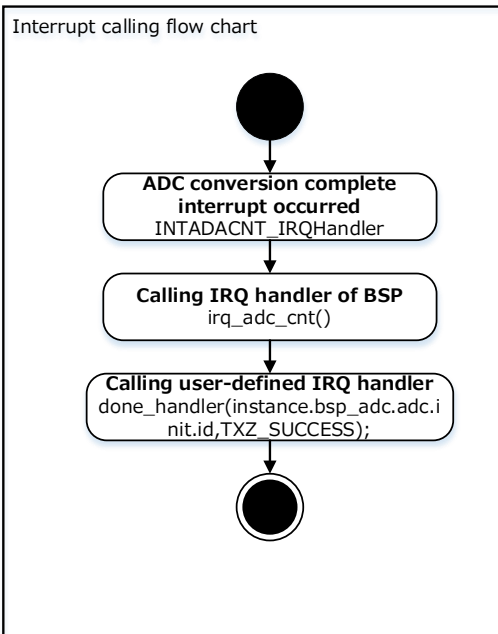
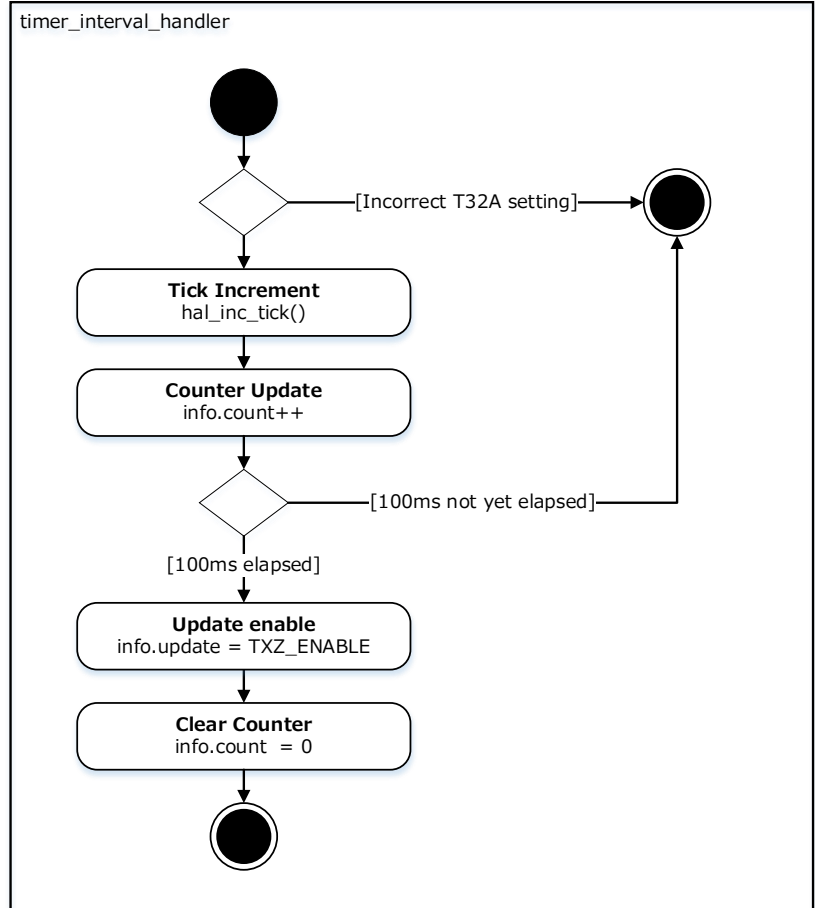
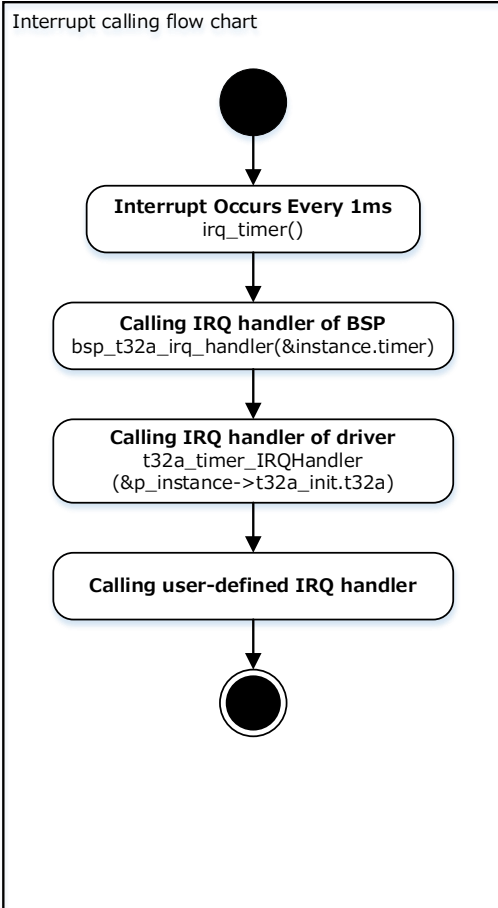
