




Fig. 6.2.1 Switching Time Test Circuit




Fig. 7.1 Marking




Fig. 8.1  $I_D - V_{DS}$




Fig. 8.2  $I_D - V_{DS}$




Fig. 8.3  $V_{DS} - V_{GS}$




Fig. 8.4  $V_{DS} - V_{GS}$




Fig. 8.5  $V_{DS} - V_{GS}$







Fig. 8.6  $V_{DS} - V_{GS}$




**Fig. 8.7  $I_D - V_{GS}$**




**Fig. 8.8  $R_{DS(ON)} - I_D$**




**Fig. 8.9  $R_{DS(ON)} - T_a$**




**Fig. 8.10  $I_{DR} - V_{DS}$**




**Fig. 8.11  $V_{(BR)DSS} - T_a$**




**Fig. 8.12  $V_{th} - T_a$**




**Fig. 8.13 Capacitance -  $V_{DS}$**




**Fig. 8.14 Dynamic Input/Output Characteristics**




**Fig. 8.15  $E_{AS}$  -  $T_{ch}$ (Guaranteed Maximum)**




**Fig. 8.16 Test Circuit/Waveform**

(Guaranteed Maximum)




**Fig. 8.19  $P_D - T_c$**
