

## 6. Sample Program:EI2C\_SLAVE\_TRANS

This is sample software that switches the LED on and off each time data reception is completed using the Slave transmission processing function of the EI2C communication function.

#### 6.1. Outlines of Operation

Turn off BSP\_LED\_2 and BSP\_LED\_3. When BSP\_PSW\_1 is pressed, the character string is sent according to the request on the Master side. The string to send is set in the 6.4 configuration. After transmission, the lighting state (turn on / turn off) of BSP\_LED\_2 is switched. When an error occurs, BSP\_LED\_3 is turn on.

#### 6.2. Function to Use

The functions to use are as follows:

For the Port assignment of each BSP channel, refer to the MCU user guide.


