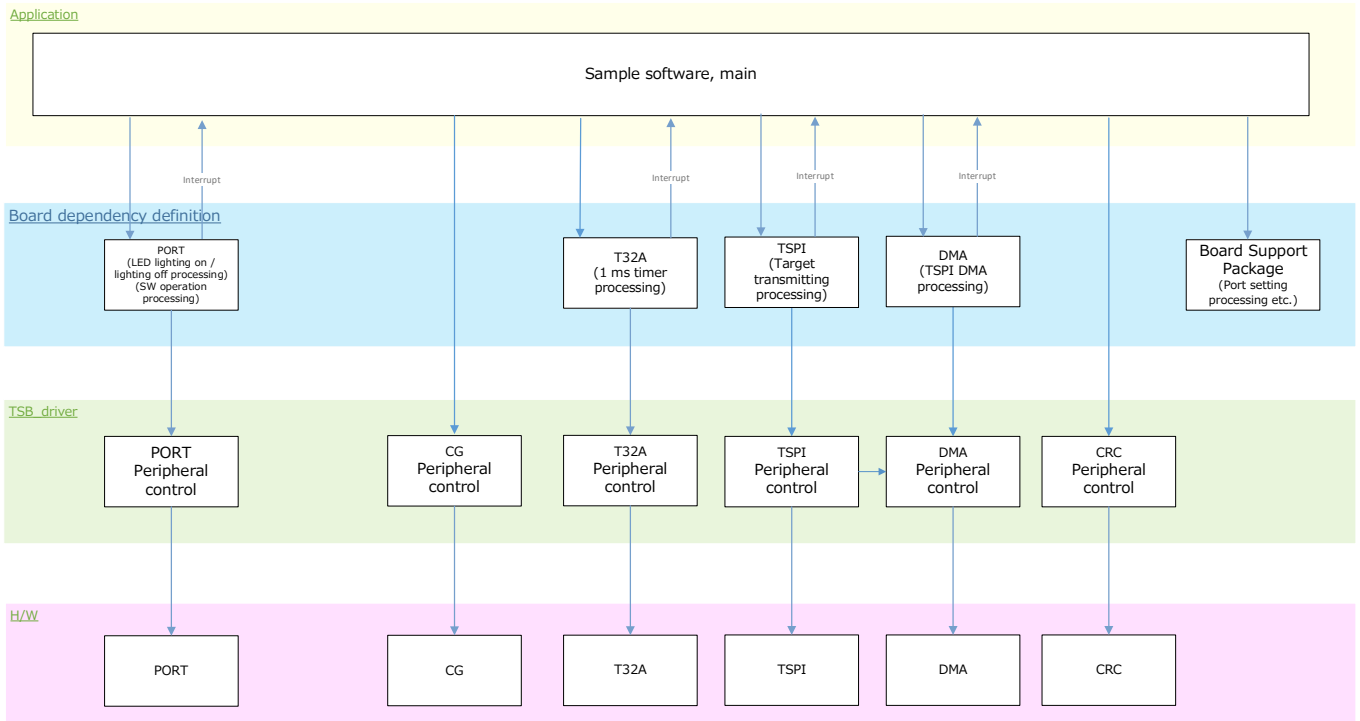

6. Sample Program: TSPI_TARGET_TRANS

This sample software uses the Target transmission processing function of the SPI communication function to switch to the transmission waiting state when the switch is pressed, and switches the LED turn on / turn off each time data transmission is completed.

6.1. Outlines of Operation

Turns off BSP_LED_2 and BSP_LED_3.

When BSP_PSW_1 is pressed, BSP_LED_3 is turned off and the data is sent according to the format according to the request from the Controller side. The data is character string 1.

Switches the lighting status (turn on / turn off) of BSP_LED_2.

When SPI write error occurs, BSP_LED_3 turns on.

6.2. Function to Use

The functions to use are as follows:

For the Port assignment of each BSP channel, refer to the MCU user guide.
