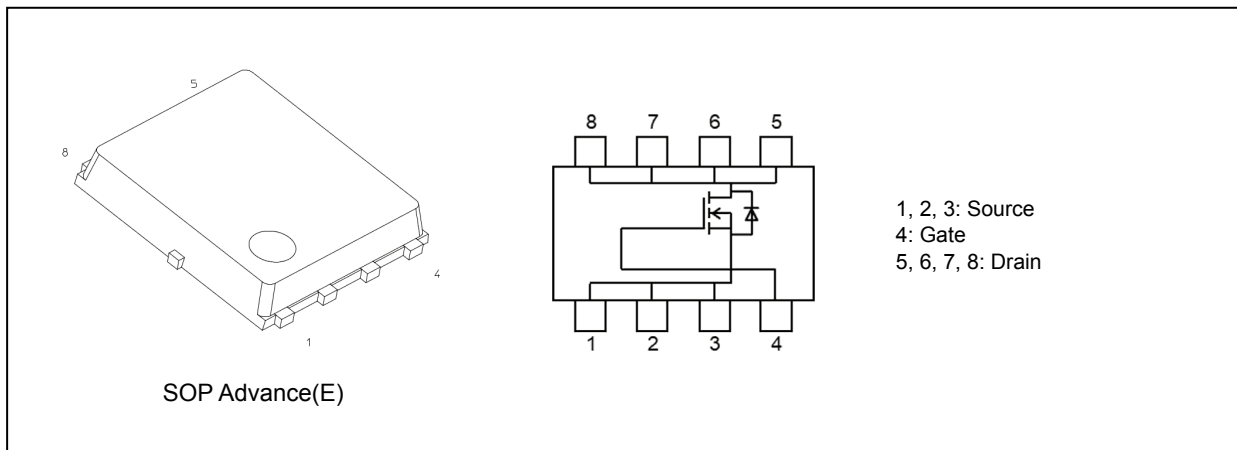

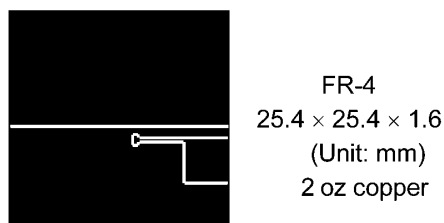


Fig. 5.1 Device Mounted on a Glass-Epoxy Board

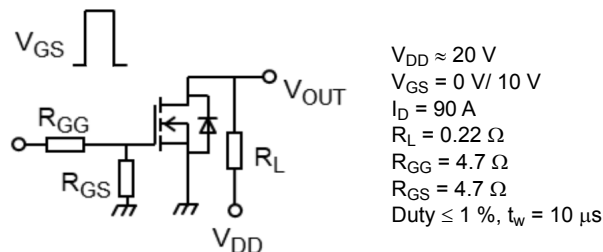


Fig. 6.2.1 Switching Time Test Circuit

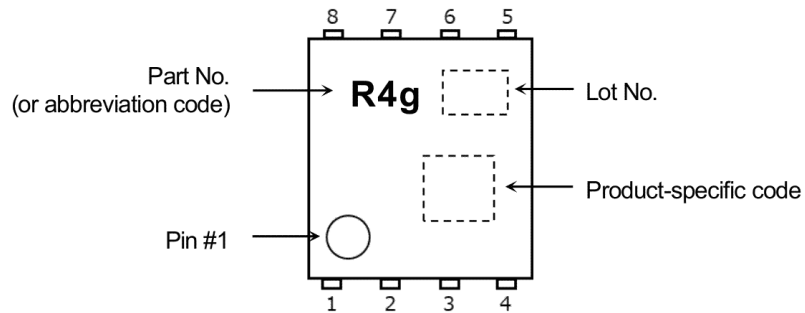


Fig. 7.1 Marking

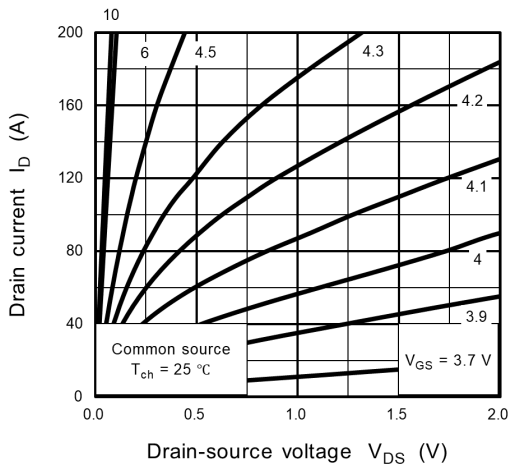


Fig. 8.1  $I_D - V_{DS}$

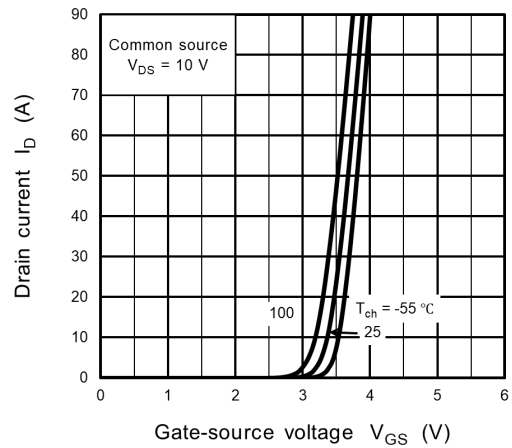


Fig. 8.2  $I_D - V_{GS}$

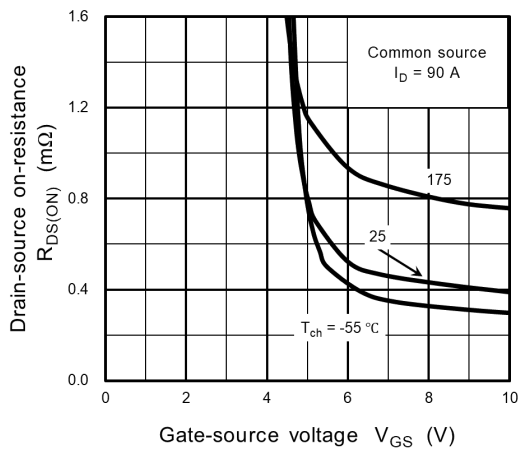


Fig. 8.3  $R_{DS(ON)} - V_{GS}$

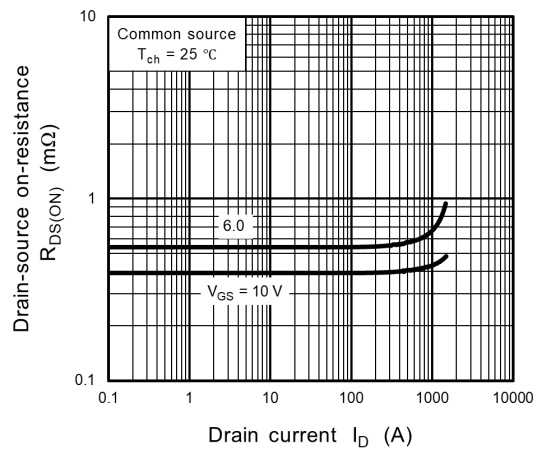


Fig. 8.4  $R_{DS(ON)} - I_D$

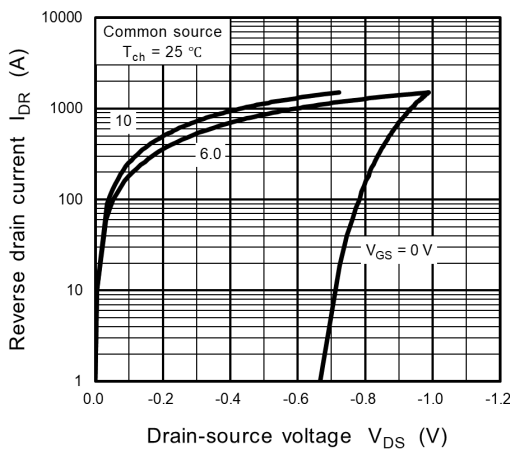


Fig. 8.5  $I_{DR} - V_{DS}$

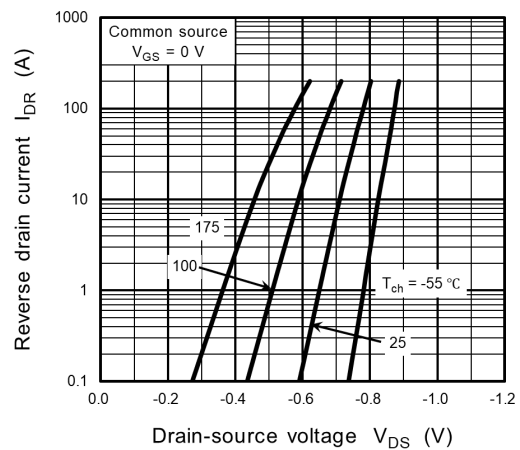
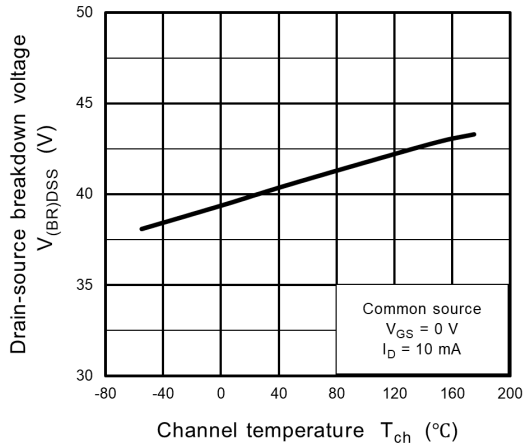
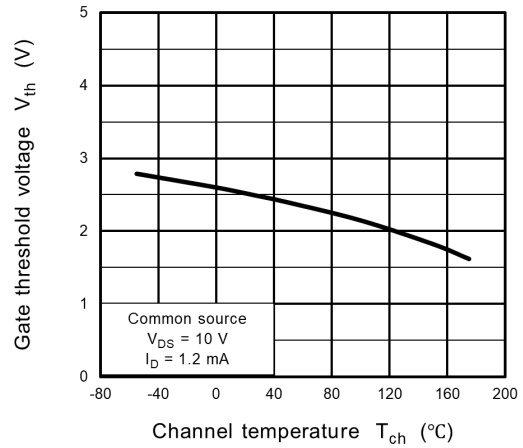


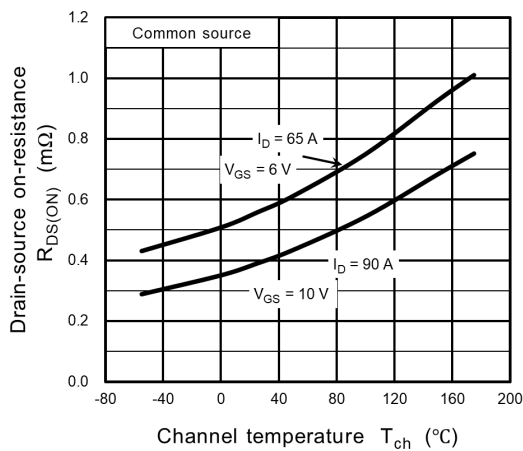
Fig. 8.6  $I_{DR} - V_{DS}$



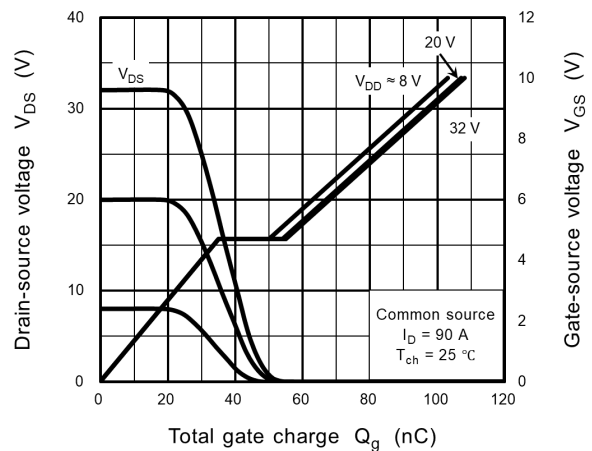
**Fig. 8.7**  $V_{(BR)DSS} - T_{ch}$



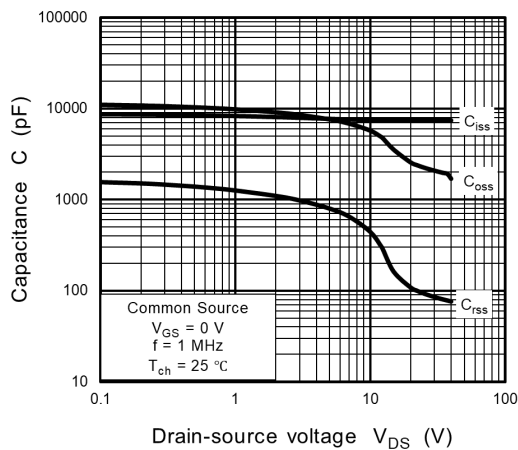
**Fig. 8.8**  $V_{th} - T_{ch}$



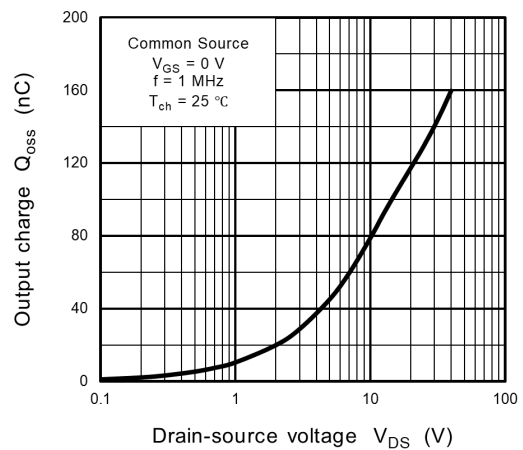
**Fig. 8.9**  $R_{DS(ON)} - T_{ch}$



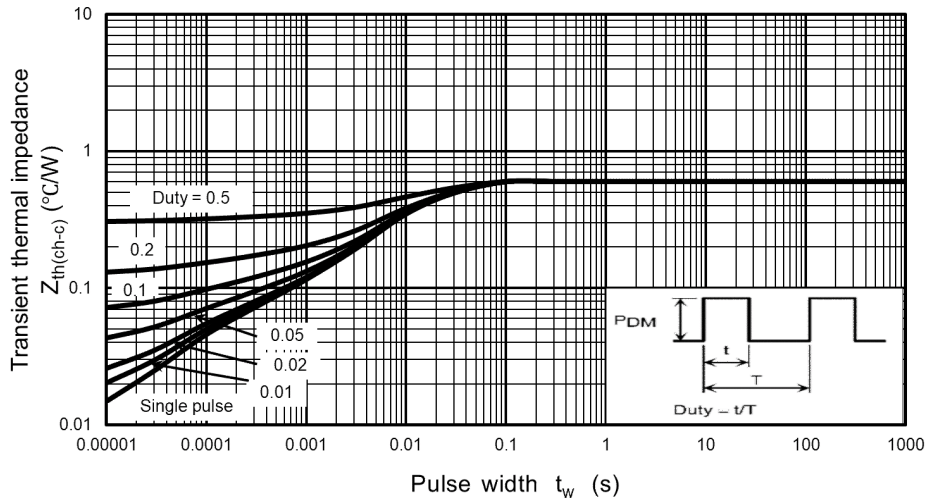
**Fig. 8.10** Dynamic Input/Output Characteristics



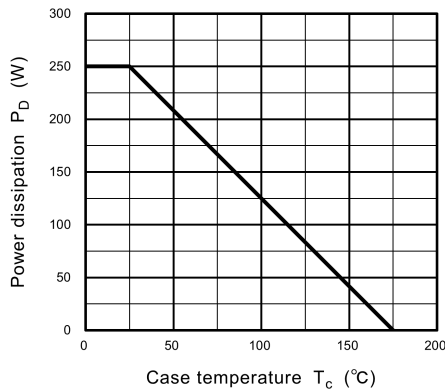
**Fig. 8.11** Capacitance -  $V_{DS}$



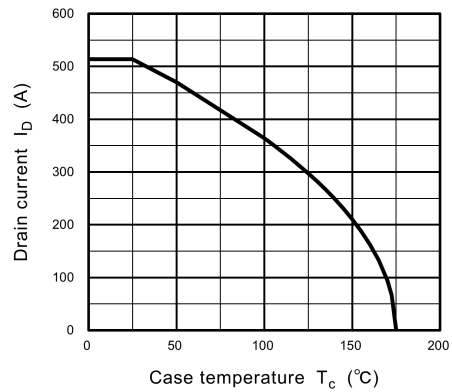
**Fig. 8.12**  $Q_{oss} - V_{DS}$



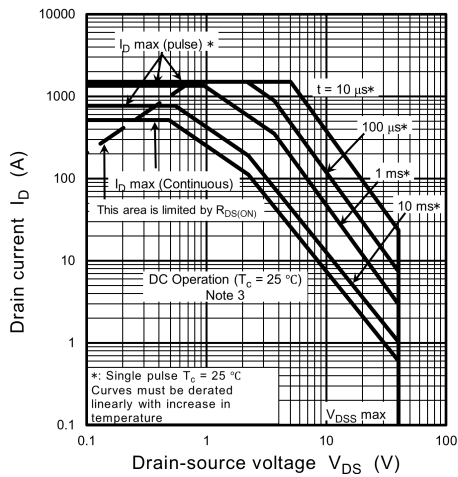
**Fig. 8.13  $Z_{th(ch-c)} - t_w$

**Fig. 8.15  $I_D - T_c$**

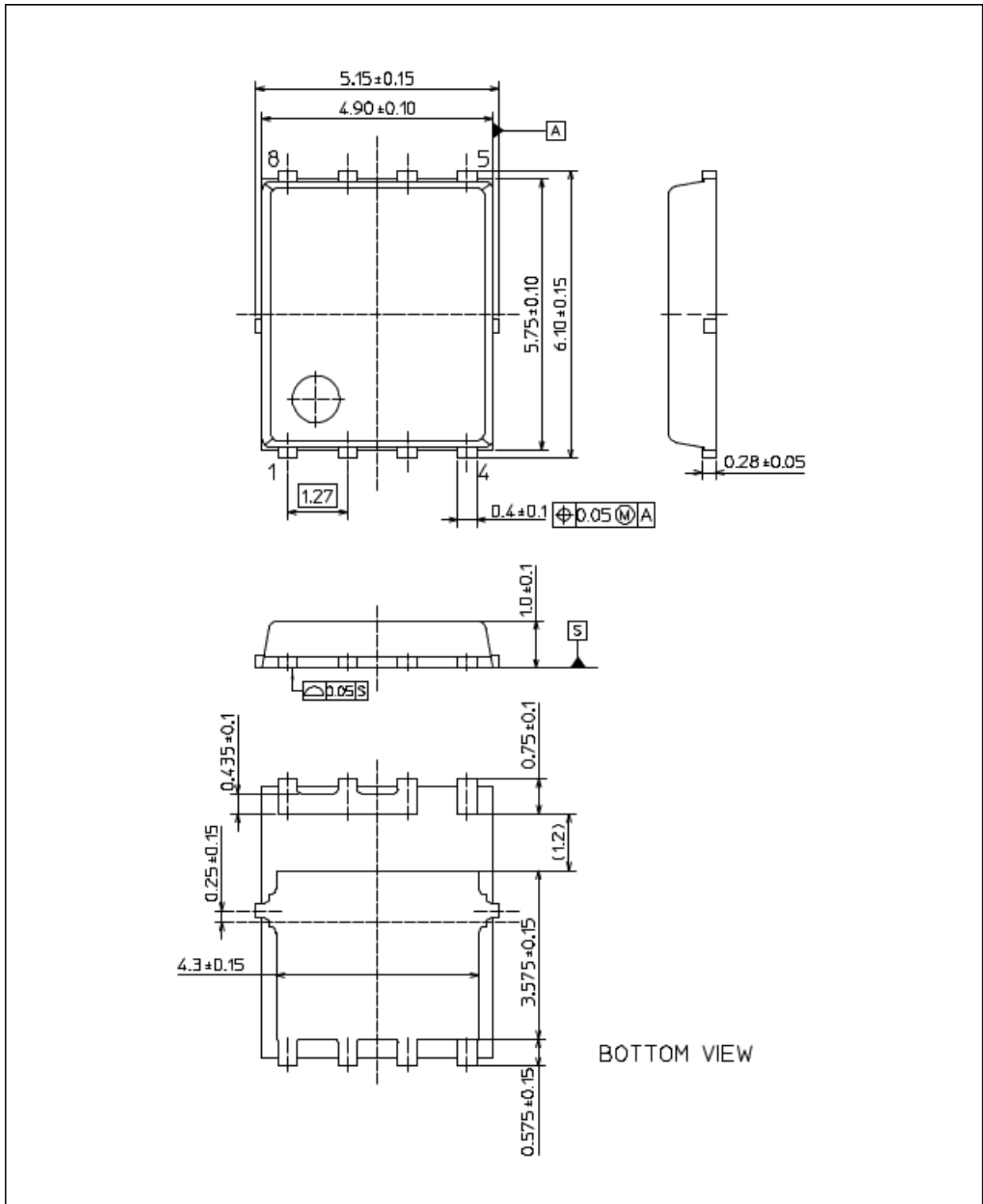


**Fig. 8.16 Safe Operating Area
