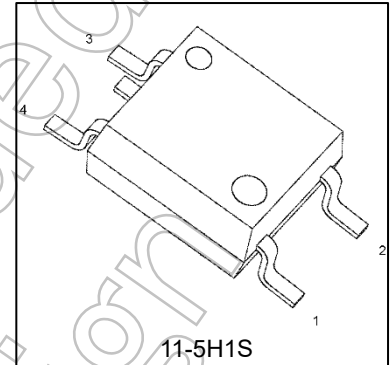
## 1. Description

The Toshiba TLP3116 consists of an infrared emitting diode optically coupled to a photo-MOSFET in a 4-pin SOP package.

This photorelay features extremely low OFF-state current and low output pin capacitance, enabling it to be used for high-frequency measuring instrument applications.

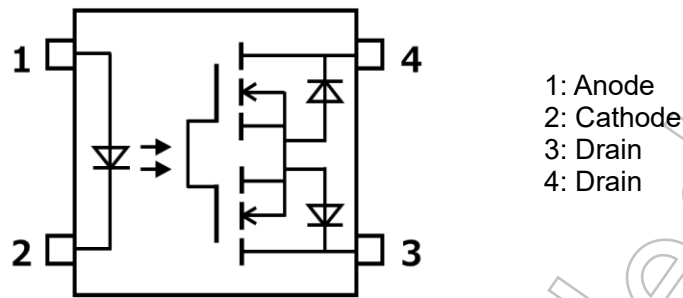

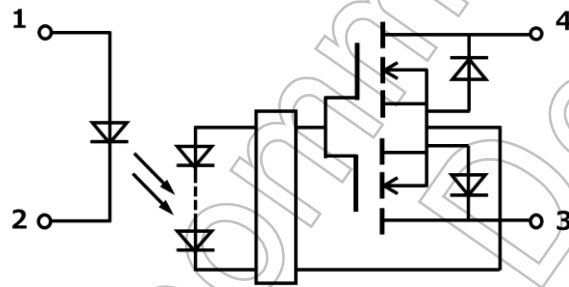

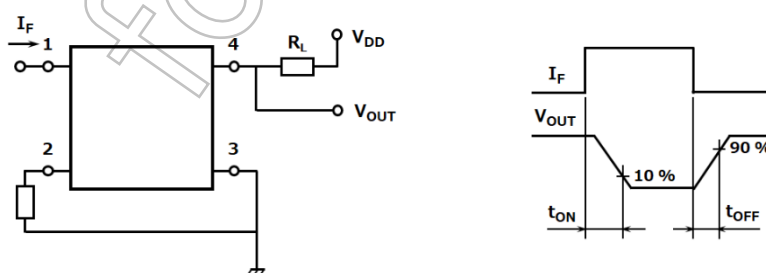
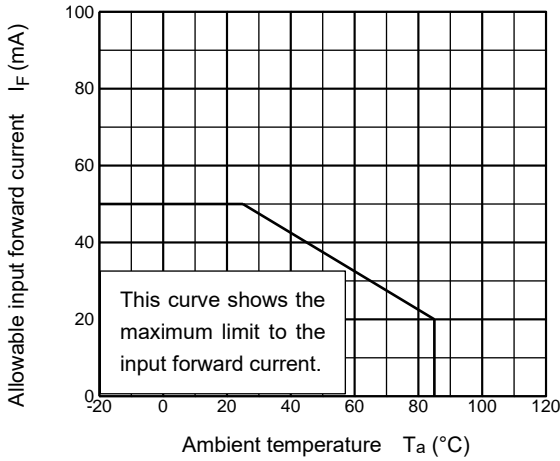
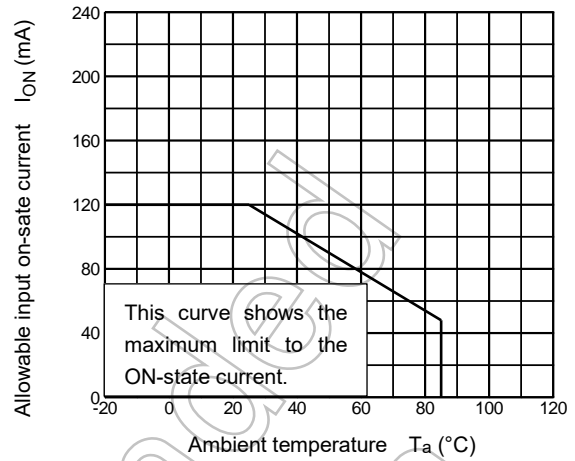


Figure 11.1 Switching Time Test Circuit and Waveform

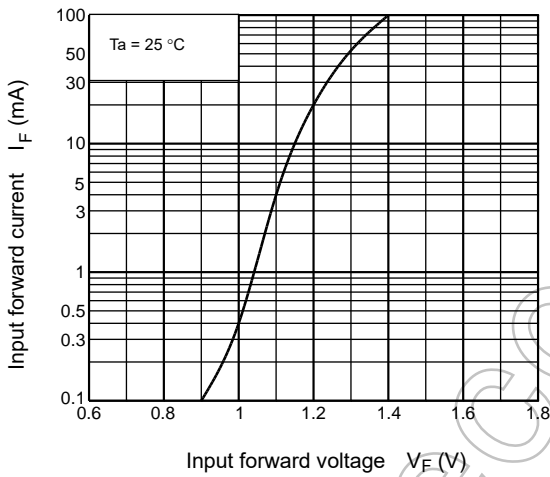

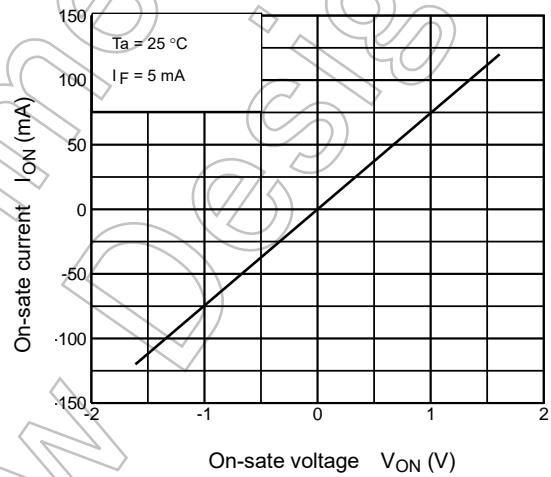
**Fig.12.1  $I_F - T_a$**



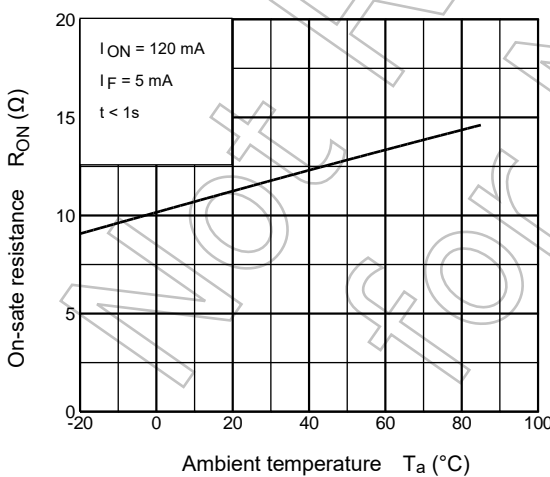
**Fig.12.2  $I_{ON} - T_a$**



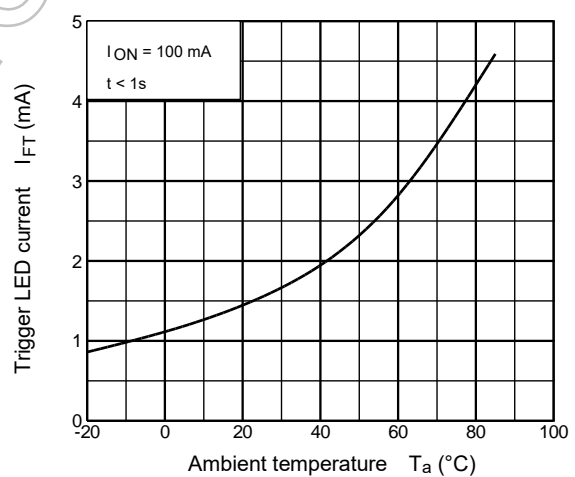
**Fig.12.3  $I_F - V_F$**



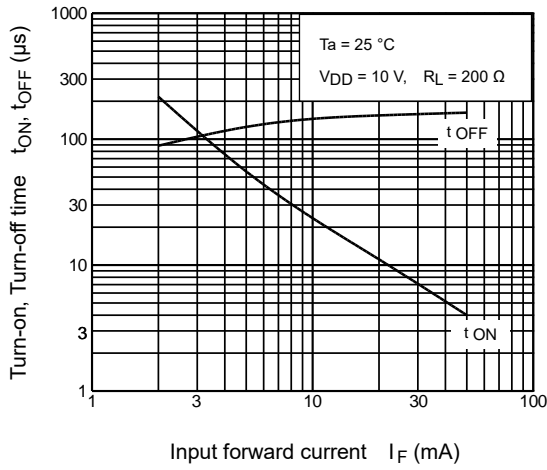
**Fig.12.4  $I_{ON} - V_{ON}$**



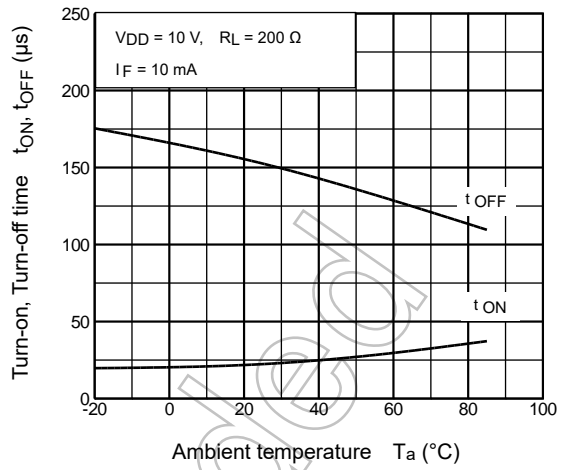
**Fig.12.5  $R_{ON} - T_a$**



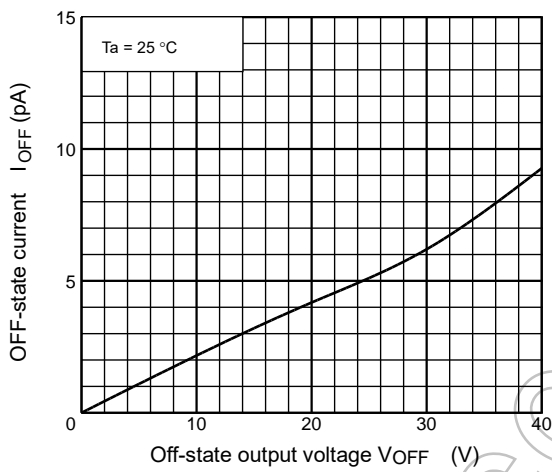
**Fig.12.6  $I_{FT} - T_a$**



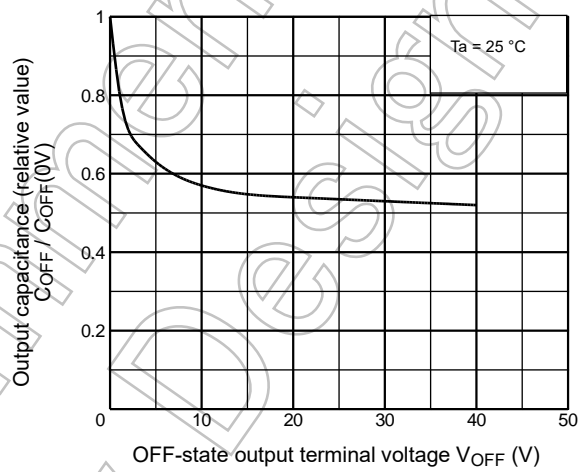
**Fig.12.7**  $t_{ON}, t_{OFF} - I_F$

**Fig.12.9**  $I_{OFF} - V_{OFF}$



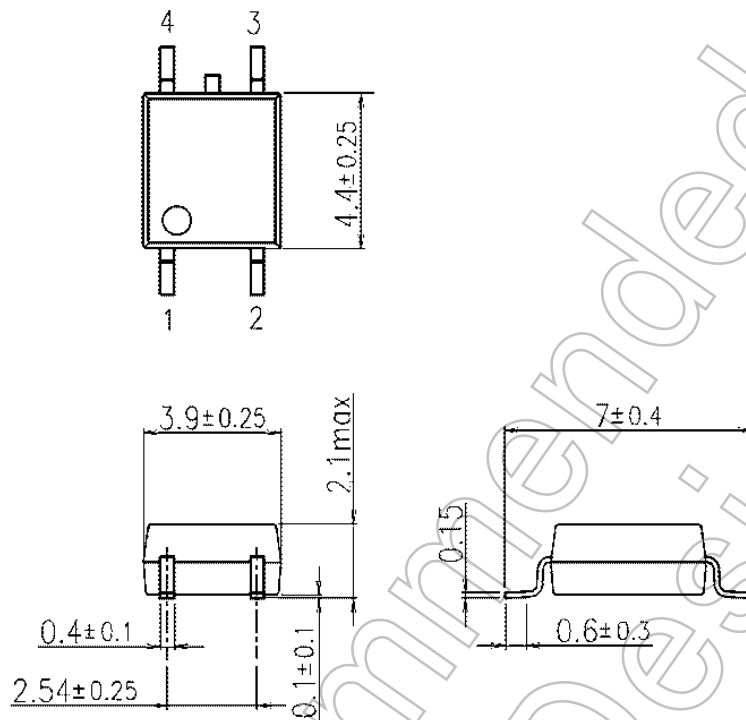
**Fig.12.10**  $C_{OFF} / C_{OFF(0V)} - V_{OFF}$
