




Fig. 13.4 Q2 I<sub>C</sub>-V<sub>I(OFF)</sub>



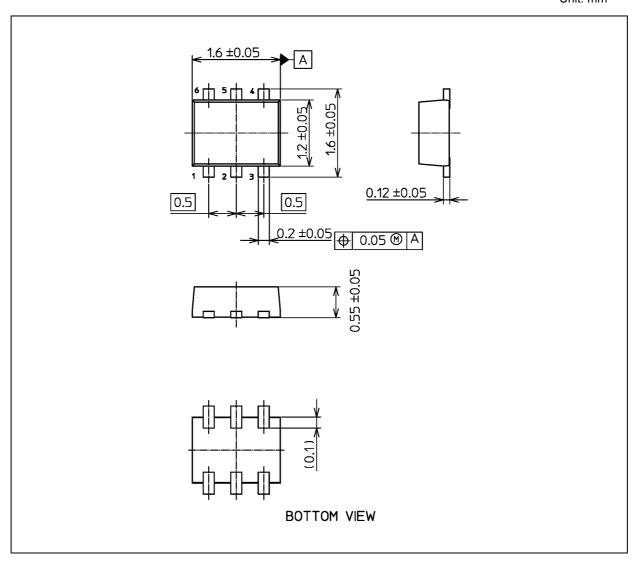
