For normal switching operation,  $V_{GS\ (on)}$  requires a higher voltage than  $V_{th}$  and  $V_{GS\ (off)}$  requires a lower voltage than  $V_{th}$ . (The relationship can be established as follows:  $V_{GS\ (off)} < V_{th} < V_{GS\ (on)}$ .)


