

2. Features

- (2) High speed operation: t_{pd} = 5.5 ns (typ.) (V_{CC} = 5.0 V, C_L = 15 pF)
- (3) Low power dissipation: $I_{CC} = 2.0 \mu A \text{ (max)} \text{ (}T_a = 25 \text{ °C)}$
- (4) High noise immunity: $V_{NIH} = V_{NIL} = 28 \% V_{CC}$ (min)
- (5) 5.5 V tolerant inputs
- (6) Balanced propagation delays: $t_{PLH} \approx t_{PHL}$
- (7) Wide operating voltage range: $V_{CC} = 2.0$ to 5.5 V
- (8) Identical pin assignment and function with TC7W14






